

MODIFICATION of SERVICES AGREEMENT

This Modification Number 2 of Contract, hereinafter referred to as Modification, is made effective and provided by and between the **Brevard Workforce Development Board, Inc., d/b/a CareerSource Brevard** hereinafter referred to as **CSB or CareerSource Brevard**, and **Sunbelt Rentals, Inc.**, hereinafter referred to as **Contractor**.

CSB and the Contractor entered into a contractual agreement effective July 1, 2020, hereinafter referred to as the Contract in this Modification, for the purpose of providing short-term and/or long-term leasing options of heavy equipment for on an as-needed basis and in support of CSB's emergency and/or disaster-related projects.
