

**MODIFICATION OF CONTRACT**

between

and

This Modification Number 4 of Contract, hereinafter referred to as **Modification**, is made effective and provided by and between **Brevard Workforce Development Board, Inc. d/b/a CareerSource Brevard** hereinafter referred to as "**CSB**" or "**CareerSource Brevard**," and **United Rentals of North America, Inc.**, hereinafter referred to as the "**Contractor**."

CSB and the Contractor entered into a contractual agreement effective July 1, 2020, hereinafter referred to as the Contract in this Modification, to provide specified equipment, as needed and specified training, with Modification Number 1 executed on July 1, 2021, and Modification Number 2 executed on October 1, 2021. Modification Number 3 executed on August 25, 2022. This Modification is written and signed to be in accordance with Section 3. G. of the agreement. All conditions of the Base Year Contract remain as-is unless addressed in Modification 1-4.

**1. Section 1: Terms of the Agreement**


CSB elects to exercise Option 3 of this Contract, hereby extending the terms through June 30, 2024.

2. This modification is effective July 1, 2023, regardless of the date of signatures. All other terms and conditions remain unchanged.


